CITY OF ADA REGULAR MEETING MARCH 20, 2023

The Ada City Council met in a regular meeting, Monday, March 20, 2023 at 5:45 p.m., at Ada City Hall, in the Dr. Ray L. Stout City Council Chamber, 231 S. Townsend. Advanced public notice was given by posting the agenda on the City Hall bulletin board on Friday, March 17, 2023 at 10:18 a.m., and posting on the City of Ada web site Friday, March 17, 2023.

The meeting of the Ada City Council was called to order by Mayor Randy McFarlin.

Mayor McFarlin led the audience in the Pledge of Allegiance.

Mayor McFarlin called for a moment of silence.

Discussion of and action on items removed from the Consent Agenda

Discussion of and action on a resolution establishing miscellaneous fees and charges as provided by the Code of Ordinances of the City of Ada, Oklahoma

Reports by City Manager and/or City Staff

Mayor McFarlin read a proclamation designating the week of March 20 - 25, 2023 as "Arbor Week", reporting that the City of Ada had received the designation of "Tree City USA" for the 28^{th} year.

Parks and Public Facilities Director, Tommy Eaton, provided information on the many improvement projects currently taking place at Wintersmith Park.

Public Information Director, Lisa Bratcher addressed the Council, speaking about the upcoming Grand Opening of Ada Main Street on Saturday, April 1, 2023, with the ribbon cutting at Juliana Park. Ms. Bratcher also spoke about the upcoming election on May 9, 2023 for the "Penny for our City" campaign.

Ms. Bratcher mentioned the bricks on Main Street removed prior to starting of the renovation of the Ada Main Street. Ms. Bratcher stated there were 3800 bricks to be returned to owners, and they are in the process of being organized, so the owners be contacted and returned to them.

Mr. Sunhawk Hill, 512 W. 10th addressed the Council, inquiring about the process of obtaining a lien reduction on property that had been abated by the City.
