The Ada City Council met in a regular meeting, Monday, August 7, 2023, at 5:45 p.m., at Ada City Hall, in the Dr. Ray L. Stout City Council Chamber, 231 S. Townsend. The meeting of the Ada City Council was called to order by Mayor Randy McFarlin.

Mayor McFarlin led the audience in the Pledge of Allegiance.

City of Ada Community Development Director, Staci Bungard, also addressed the Council, providing further information as to Mr. Scroggins responsibilities if he plans to correct the property.

City Manager Holcomb reported the current Ada Main Street contract requires for any unused funds to be returned to the City of Ada. Mr. Holcomb explained the amended contract would make the original contract void and keep the contracted amount the same in the amount of \$80,000.00, while allowing for the remaining funds of \$15,944.00 also used by Ada Main Street funds on contracts agreed upon by the Ada Main Street Committee.

The President of Ada Main Street, Mr. Trevor Sutton addressed the Council on how the committee planned to utilize the excess funds of \$15,944.00 for events during the Christmas season, such as Snow Mazing, World's Largest Snowman Bounce and Snowzilla, Jr., this December.

Motion was made by **Council Member Vazquez**, seconded by **Council Member Hudson** to approve amending 2023-2024 Ada Main Street Contract, to include \$15,944.00 for contracted events during the Christmas Season of 2023. Mayor McFarlin called for a vote taken with the following result:
