- b. Discussion of and action on the Approval of a Final Plat for The Colony Addition to the City of Ada, Oklahoma

Community Development Director, Staci Bungard, presented to the council regarding the approval of the Final Plat for Colony Drive. The Plat includes two tracts totaling 31.722 acres and is zoned Office Commercial District (C-O), Neighborhood Commercial District (C-1), and General Commercial District (C-2). The property is currently un-platted and is being used as office buildings. Staff recommend approval with two contingencies regarding waterlines.

Council member Johnson questioned what is within the districts and if it was relevant to the decision. Bungard clarified that the area is currently office space and that it was not relevant since office space already exists there.

Jim Sanders, from 1120 Colony Drive, spoke in favor of the item, expressing hope for a long-term plan to industrialize the area.

Library Director Jolene Poore reminded the council of the upcoming event, Americans and the Holocaust Exhibition, which will start on December 4th and run through January 8th.


