## CITY OF ADA REGULAR MEETING JANUARY 17, 2023

The Ada City Council met in a regular meeting, Tuesday, January 17, 2023 at 5:45 p.m., at Ada City Hall, in the Dr. Ray L. Stout City Council Chamber, 231 S. Townsend.
